- (iv) Image of 100 words write-up as to why your (petitioners) services is required to be provincialised inspite of the fact that the date of recognition/permission does not fulfill the provision of the Provincialisation Act 2017 (preferably in bullet points).
- (v) The documents must be submitted in chronological order as per serial above. No other documents except serial (i) to (iv) as above should be uploaded in the mail.
- (vi) The above stated documents should be clear and readable and shall be mailed to sschooldata90@gmail.com

FOR UPPER PRIMARY SCHOOLS:


- (i) Photocopy of the order of recognition of the school (self attested).
- (ii) Photocopy of any document (maximum 3 pages) that indicates the date of submission of proposal of permission/recognition.
